Subject: Regarding No objection Certificate upto 10th to S.S.M.Global School, Kassoana Ferozepur for getting 10th level affiliation from C.B.S.E.

Sir,

In reference to above cited subject:

After considering the documents along with affidavit presented by School Management, recommendation of District Education Officer (SE) Ferozepur and Director Education Department (SE), Punjab, Chandigarh, the Punjab Govt. issue required No Objection Certificate object to the following conditions:-

1. in future on the ground of complaint/inspection, if it is found that at the time of getting No Objection Certificate you have given application on the basis of wrong information and/or you have not implemented instructions issued by the Punjab Govt. time to time and conditions written in affidavit have been denied then in those cases at any moment this No Objection Certificate can be forfeited.
2. In your school teaching of Punjabi subject will be compulsory upto 10th and C.B.S.E. Board will force these schools for taking examination of Punjabi and it is also said that in case of denying No Objection Certificate can be forfeited.
3. School Management will implement Notifications issued under the RTE Act, 2009 by Education Department Punjab Government and Rules framed under the RTE Act, 2009 for Punjab State.
4. After getting affiliation of C.B.S.E. Board the School Management will be bound to pay Teaching and Non-teaching staff of school at par with the pay and allowances of Govt. Employees through account payee cheques. At the time of extension/upgradation the school will deposit reserve fund for teaching and non teaching staff according to the direction of Govt. to the District Education Officer (SE). Otherwise No Objection Certificate can be forfeited immediately.
5. You yourself and yours management will also ensure that if and when Education Officer of your district or any Senior Officer of Education Department require any information then required information will be supplied to him and will also be given required support. Otherwise No Objection Certificate can be forfeited immediately.

6. The requirements for child safety, public health sanitation and other No Objection Certificates will be inspected periodically by the Punjab Government officials. No objection certificate can be forfeited immediately.
7. The guidelines according to letter no. 2/93/2009/3S3/1360154 dated 26.11.2018 issued through should be followed differently.
